- 2. Consists of 19,202,652 shares of Class B Common Stock held by Atlas Capital Resources (A9) LP ("ACR A9"), 6,895,120 shares of Class B Common Stock held by Atlas Capital Resources (A9-Parallel) LP ("ACR Parallel") and 702,528 shares of Class B Common Stock held by Atlas Capital Resources (P) LP ("ACR P"). Atlas Capital Resources GP LLC ("ACR GP") is the general partner of Atlas Capital GP LP ("ACR GPLP"). ACR GPLP is the general partner of ACR A9, ACR Parallel and ACR P. ACR GP, ACR GPLP, ACR A9, ACR Parallel and ACR P are collectively referred to as the "Atlas Entities." Andrew M. Bursky and Timothy J. Fazio are each a managing Partner of ACR GP and may be deemed to control the Atlas Entities.
- 3. Each of Messrs. Bursky and Fazio and each of the Atlas Entities disclaims beneficial ownership interest of the Class B Common Stock except, in each case, to the extent he or it has any pecuniary interest therein.
